MAKE CHECKS PAYABLE TO MERRITT TOWNSHIP

A PLAN REVIEW may be required before work is started on any building other than a single family dwelling less than 3,000 square feet, or wiring or alteration to an electrical system that costs more than \$10,000.

Section 23a of the State Construction Act of 1972, Act No. 230 of the Public Acts of 1972, being Section 125 of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or residential structure. Violators of Section 23a are subject to civil fines.

I agree to abide by all requirements of the electrical code including calling for inspection before any electrical work is covered or used, and upon completion, I will accompany the inspector during the inspection when requested by the electrical inspector.

### HOMEOWNER AFFIDAVIT

I hereby certify the electrical work described on this permit application shall be installed by myself in my own home in which I am living or about to occupy. All work shall be in accordance with the STATE OF MICHIGAN electrical code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the electrical inspector.
